All ETEN members agree to the following policies upon joining.

1

## Antitrust Compliance

No discussions of pricing, market allocation, bid coordination, or competitive strategies during ETEN meetings or events. All participants are expected to comply with federal and state antitrust laws. Members acknowledge this obligation upon joining.

## Vendor Selection

To ensure balanced representation, vendors are selected based on criteria including technology solutions offered, populations served, company size, and other relevant factors. The ETEN aims to bring together a diverse group of established leaders and emerging innovators.

## Non-Endorsement

Participation by state agencies does not constitute endorsement of any member's products or services. Members may not represent the ETEN membership, state participation, or advisory involvement as an endorsement in any marketing, sales, or promotional materials.

## Code of Conduct

ETEN meetings are collaborative, not sales-oriented. Members shall respect the roles and time of state leaders; refrain from direct product solicitation during collaborative sessions; and maintain professional conduct at all ETEN events and in all communications.

## Brand Usage

Members may reference their ETEN membership status with prior approval from ADvancing States. Use of the ETEN, ADvancing States, or NASDDDS names, logos, or trademarks requires written permission. No member may imply a partnership, joint venture, or endorsement relationship beyond their membership.

Conference opt-in registration lists are provided exclusively for professional outreach related to ETEN activities. Members may not sell, transfer, or share this data with third parties, nor use it for mass unsolicited marketing. All use must comply with the CAN-SPAM Act and applicable state privacy laws.

## Confidentiality & Intellectual Property

Discussions during ETEN meetings are confidential. Members may not attribute, quote, or use statements made by state officials or other participants in marketing materials without prior written consent. Materials and resources produced by the ETEN are the property of ADvancing States and NASDDDS.



# Legal Terms

By joining the ETEN, members agree to the following terms and conditions.

## Force Majeure

If any ETEN event is cancelled, postponed, or converted to a virtual format due to circumstances beyond the control of ADvancing States or NASDDDS — including but not limited to pandemic, epidemic, public health emergency, government order, natural disaster, acts of war, terrorism, or severe weather — ADvancing States shall not be liable for any damages or losses. Year-round network benefits remain in effect regardless of conference status.

## No Guarantee of Attendance or Results

Attendance figures, statistics, and demographic data presented in this prospectus reflect prior-year actuals and are not guarantees of future attendance, booth traffic, or business outcomes. ADvancing States makes no express or implied warranty regarding the number or type of attendees at any event.

## Government Procurement & Ethics

ETEN membership does not confer any preferential treatment, advantage, or consideration in state or federal procurement processes. Members are solely responsible for understanding and complying with all applicable state and federal ethics rules, gift restrictions, and lobbying disclosure requirements.

## Accessibility

The ETEN is committed to accessible, inclusive events. Members receiving booth space must ensure their exhibits are accessible to individuals with disabilities in accordance with the ADA. Given the ETEN's mission, members are expected to demonstrate accessibility in their event presence.

## Non-Transferability

Membership is held by the member organization and is non-transferable. Members may not assign, sell, or transfer membership rights or benefits to any other company or entity without prior written consent. Personnel may be substituted with advance notice.

## Indemnification & Hold Harmless
